For Planning Staff to complete a review of your proposal, a concept site plan detailing the proposal (in metric units) is required and shall include:

- lot boundaries and dimensions
- dimensions and use of proposed buildings/structures
- dimensions and use of existing buildings/structures
- location of all buildings and structures in relation to the lot boundaries
- location of services (i.e., utility pole, septic system, etc.)
- driveway and parking areas

For proposals to create a new lot, sever land, or similar, the following additional information is required to be provided:

- area of lands to be retained and lands to be severed
- dimensions of lands to be retained and lands to be severed
- distance between proposed lot boundaries and buildings/structures

Staff encourage other relevant information to be provided such as: elevation drawings, floor plans, permits and/or correspondence from outside agencies (i.e., Parks Canada), etc.
