- lot boundaries and dimensions
- dimensions and use of proposed buildings/structures
- dimensions and use of existing buildings/structures
- location/setbacks of all buildings and structures in relation to the lot boundaries
- location/setbacks of services (i.e., utility poles/wires, septic system, etc.)
- driveway and parking areas

Site plans shall be professionally prepared and based on an OLS survey. Any alternative site plan formats may be accepted subject to the satisfaction of Township Staff, and the applicant may be required to provide OLS verification of setbacks prior to pouring of footing/foundation.

Additionally:

Where a building is being proposed, elevation and floor plans are also required.


On Georgian Bay, drawings for new, additions and alterations thereto, dwellings and sleeping cabins must show the minimum opening elevation (as outlined and defined in the Zoning By-law).

Drawings require a title, date, number and name of who prepared the drawing(s).
