Notice is hereby given that as of Friday, May 1, 2026 at 8:30 AM nominations may be filed in-person or by agent, in the Clerk's office during regular office hours by appointment only through to Nomination Day on Friday, August 21, 2026 from 9:00 AM to 2:00 PM.

Nominations may be made by completing and filing in the office of the Clerk, nominations on the prescribed form and accompanied by the Declaration of Qualification, acceptable identification, and the prescribed nomination filing fee of \$200 for the Head of Council and \$100 for all other offices. The filing fee is payable by cash, debit, certified cheque, bank draft, or money order.

Nomination papers must be filed with the Municipal Clerk before you can accept contributions or spending money for your campaign.

Candidates for the Offices of Mayor and District Councillor, please take note that if elected you will also serve as a Member of Council for the District of Muskoka.


